

8 Legatees respectively as aforesaid And I do hereby order and direct  
that the said Legacies so given and bequeathed by me shall be paid  
to my said Legatees their Executors Administrators or assigns out  
of my said real Estate at the End of twelve Months next after my  
said Nephew Joseph Smith or his Heirs shall come into the possession  
9 thereof. I give and bequeath to my Wife Isabella Smith such of my  
Household Furniture as will be sufficient to furnish her a house  
inadecent manner. All the rest residue and remainder of my House-  
hold Furniture, Cattle, Chattels personal Estate and Effect what-  
soever I give and bequeath unto my said Trustees and the Survivor  
of them and the Executors Administrators and Assigns of such  
10 Survivor Upon Trust that they my said Trustees do and shall as  
soon as conveniently may be after my decease sell dispose of and  
convert into Money and pay one half of the produce thereof unto  
my said Wife to whom I give and bequeath the same And as to the  
other half thereof that they my said Trustees do and shall from to  
11 time to time put and place the same out at Interest, together with  
any Surplus that may arise from or out of the Rents and Profits of  
my said real Estate over and above the Expenses of the Maintenance  
Education and bringing up of my said Son, upon Mortgage or some other  
eligible Security or Securities at their Discretion for the Benefit  
and Advantage of my said Son his Executors Administrators or Assigns  
12 Provided nevertheless and it is my Will and Mind that if my said Son  
shall happen to die before he attain his said Age of Twenty one  
Years leaving no lawful Issue that then and in such case my said  
Trustees shall call in the Money so at Interest and pay and divide  
the same unto and equally amongst all and every of my Nephews and  
Nieces who shall be living share and share alike to whom I give  
and bequeath the same accordingly And it is my Will and Meaning  
13 that my said Trustees or either of them shall not be liable to  
answer or make good any loss or losses that shall or may happen to  
the said Trust Estate in placing out the said Monies to Interest  
according to the directions of this my will or in transacting any  
Money Money Affairs or otherwise relating to or concerning the  
Execution of the Trusts hereinbefore mentioned unless the same  
14 shall appear to happen by or through their or either of their  
wilful neglect or default nor shall either of them my said Trustees  
be answerable or accountable for the Acts Deeds Receipts or  
Disbursements of the other of them but each of them shall be  
answerable only for his own seprate Acts Deeds Receipts and Disbur-  
Disbursements. And I do hereby direct that my said Trustees shall  
and may pay and reimburse themselves and himself out of any Money  
15 that may come into their Hands by Virtue of this my Will all such  
reasonable and necessary Costs Charges and Expenses whatsoever  
together with a reasonable Compensation for their and each
