All the rest residue and remainder of my Household Furniture, Cattle, Chattels personal Estate and Effect whatsoever I give and bequeath unto my said Trustees and the Survivor of them and the Executors Administrators and Afsigns of such Survivor Upon Trust that they my said Trustees do and shall as soon as conveniently may be after my decease sell dispose of and 10 convert into Money and pay one half of the produce thereof unto my said Wife to whom I give and bequeath the same And as to the other half thereof that they my said Trustees do and shall from to time to time put and place the same out at Interest, together with any Surplus that may arise from or out of the Rents and Profits of my saidreal Esate over and above the Expenses of the Maintainance Education and bringing up of my said Son, upon Mortgage or some other eligible Security or Securities at their Discretion for the Benefit and Advantage of my said Son his Executors Administrators or Afsigns Provided nevertheless and it is my Will and Mind that if my said Son shall happen to die before he attain his said Age of Twenty one Years leaving no lawful Ifsue that then and in such case my said 12 Trustees shall call in the Money so at Interest and pay and divide the same unto and equally amongst all and every of my Nephews and Nieces who shall be living share and share alike to whom I give and bequeath the same accordingly And it is my Will and Meaning t that my said Trustees or either of them shall not be liable to answer or make good any lofs or lofses that shall or may happen to 13 the said Trust Estate in placing out the said Monies to Interest according to the directions of this my will or in transacting any Money Affairs or otherwise relating to or concerning the Execution of the Trusts hereinbefore mentioned unlefs the same shall appear to happen by or through their or either of their wilful neglect or default nor shall either of them my said Trustees 14 be answerable or accountable for the Acts Deeds Receipts or Disboursements of the other of them but each of them shall be answerable only for his own seprate Acts Deeds Receipts and Disbour Disboursements. And I do hereby direct that my said Trustees shall and may pay and reimburse themselves and himself out of any Money that may come into their Hands by Virtue of this my Will all such 15 reasonable and necefsary Costs Charges and Expenses whatsoever together with a reasonable Compensation for their and each
